

What Motorcycle Insurance Do You Need to Protect Yourself & Your Family?



Washington requires motorcycles to be covered under liability insurance. Choosing to carry insurance is one of the essential safety precautions that a biker can take, not only for him or herself, but also for the passengers and your family.

Motorcycle riders must purchase liability insurance in Washington State, which was a change in the law that took place in July of 2019. Motorcyclists are now **REQUIRED** to purchase the following coverage:

- > \$25,000 in bodily injury
- > \$10,000 in property damage liability insurance
- > \$50,000 for injury per accident

However, these coverages only cover vehicles that you are at-fault for hitting in an accident. You are not covered for your injuries or your bike's damages. You must buy extra coverage for that – which we **HIGHLY** recommend you do.

Uninsured/Underinsured Motorist Bodily Injury and Property Damage (UM/UIM)

UM/UIM is the MOST important insurance you can get! It is the best way to protect you and your family from financial disaster after a serious injury accident. UM/UIM kicks in when the at-fault driver's insurance isn't enough to cover your medical bills, lost wages, and pain and suffering. This coverage only applies to accidents where someone else is at least partially responsible for causing the accident.

Below are all the Motorcycle insurance coverages we recommend:

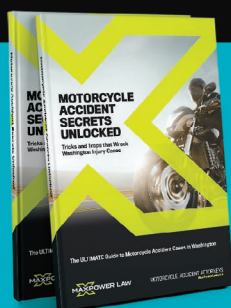
